## **NOTES:**

- 1) Please note that the the Ground Safety for Marines (GSM) course prerquisite material for each student; Appointment Letters, Statements of Availability, and rank appropriate Risk Management certificates from MarineNet will be due to the Base Safety Center (CID M10M8SA) NLT than the published document deadline or the student will be dropped from the course. This is to ensure course quota requirements have been satisfied, to enter nominees into Marine Corps Information Management System (MCTIMS), and to ensure students can receive pertinent course information in advance of the published start date.
- 2) There are minimum and maximum quota requirements set forth by TECOM, so please relay your nomination requests through your safety chain of command as soon as possible.
- 3) Please send all corresponding information regarding the GSM course through the Unit Safety Officer or Manager. This eliminates the Base Safety training staff from attempting to process 30 individuals, individually. All Appointment Letters, Statements of Availability, and rank appropriate Risk Management certificates will be obtained by Unit Safety Officers and Managers and sent to the Base Safety Training email @ CPEN\_SAFE\_TRNG@usmc.mil.

**PREREQUISITES**: USMC E-6 and above, O-1 or higher serving in ground safety billets, or GS civilian serving in ground safety billets. All personnel must have at least 12 months remaining until their end of active service (EAS) from the course completion date. All personnel must complete the <u>rank appropriate Risk Management course</u> on MarineNet and email the completion certificate, their statement of availability, and a copy of their safety appointment letter prior to the document deadline dates. Attendees who do not meet the prerequisites will not be granted a seat.
