Subj: EXCLUSIVE SHOPPING HOURS FOR SPECIFIC PATRON CATEGORIES
AT CAMP PENDLETON COMMISSARIES DURING THE COVID-19 CRISIS

Ref: CG MCIWEST ltr 4065 over G-4 dtd 26 Mar 2020

1. Reference (a) is cancelled and replaced by this letter. The COVID-19 crisis has caused a disruption to normal availability of commissary items. It has also made commissary patrons anxious about their ability to procure groceries while providing better social distancing for at risk individuals. In order to mitigate those concerns and provide all patrons an opportunity to shop at the start of the day, after evening restocking, the following exclusive shopping hours are recommended in paragraph 2. Store directors always have the authority to immediately alter store hours and access to ensure a safe shopping environment.

2. Exclusive access to shop will be as follows:
