COURSE REGISTRATION: Submit nomination letters (Attachment A) to the Training Section via email, routed through your unit's Environmental Compliance Coordinator (ECC). Ensure all nominations bear a hand or digital signature and are submitted no later than two weeks prior to the course start date. Course check-in is scheduled for 0715, with instruction commencing at 0730 in Building 2282.

* Prior to attending Hazardous Waste Handler Course, students must complete the USMC Introduction to Hazardous Materials/Hazardous Waste online pre-requisite, accessible via Marine Net. Upon completion, upload the certificate to the Marine Net MOODLE site and complete the assigned pre-course reading. Students will receive an email from Marine Net MOODLE providing access and instructions for completing eight hours of asynchronous training prior to the

in-class portion of the course. Failure to complete the Marine Net pre-requisite and Phase I asynchronous training may result in disenrollment.

** The Hazardous Material Operators Course requires completion of the USMC Hazardous Material Transportation for Drivers online pre-requisite, available on Marine Net. Students must upload the completion certificate to Marine Net MOODLE and complete the assigned reading for Lesson One as the initial assignment.

In addition, I MEF mandates completion of the Security Awareness class, accessible at <http://dothazmat.vividlms.com/>. New users should click "register now" and subsequently enroll in "8.0 Security Requirements." Submit the course certificate to your licensing official.

*** The monthly Environmental Compliance Coordinator Meeting (ECM) for unit ECCs is held on the second Tuesday of each month from 1330-1430 in Building 2282. All military and civilian personnel with Hazardous Materials/Hazardous Waste environmental responsibilities are required to attend per MCIWEST-MCB CAMPENO 5090.5A MARINE CORPS BASE, CAMP PENDLETON COMPREHENSIVE ENVIRONMENTAL TRAINING AND EDUCATION PROGRAM and MCO 5090.2 V5 040605.

Course Nominations, AMOS 8056 and Points of Contact

Requirements

1. Unit Environmental Compliance Coordinators (ECC) must submit course nomination letters, ensuring they are hand or digitally signed. Forward completed nominations and training requests to [PNDL Training Environmental Security@usmc.mil](mailto:PNDL_Training_Environmental_Security@usmc.mil).
2. Personnel seeking AMOS 8056 (HM/HW Marine) must complete the following steps:
 - **Step 1:** Attend the classroom Hazardous Material/Hazardous Waste (HM/HW) Handler course.
 - **Step 2:** ECCs and AMOS applicants should review the requirements outlined in Attachment B, available at: <https://www.pendleton.marines.mil/Main-Menu/Staff-Agencies/Environmental-Security/Document-Library/Environmental-Training/>.
 - **Step 3:** Complete all installation-specific additional training courses (see Attachment B).
 - **Step 4:** Submit the signed AMOS 8056 checklist to the Environmental Security Training Section (Building 2282) for approval by MCB Camp Pendleton CETEP.
 - **Step 5:** Obtain the Commanding Officer's signature on the completed checklist and submit the package to the Training Office (Building 2282) for AMOS certification. Subsequently, submit the complete package to IPAC.
