Please be advised that the County of San Diego Department of Environmental Health, Solid Waste Local Enforcement Agency (LEA) will be conducting an Informational Meeting in compliance with California Code of Regulations, Title 27, Section 21660.2 for the revision of the San Onofre Landfill Solid Waste Facility Permit (SWFP), SWIS #37-AA-0902.

San Onofre Landfill is an existing permitted solid waste landfill with an operational area of 64.4 acres located at Marine Corps. Base Camp Pendleton, 2.7 mile east of the Basilone gate on Basilone Road, Camp Pendleton, CA 92055. On May 4, 2020, the LEA accepted for processing a SWFP application package from the United States Marine Corps. Base Camp Pendleton. The LEA has made a preliminary determination to approve the revised San Onofre Landfill SWFP.

The proposed permit revision includes an:

- Increase to the permitted daily tonnage from 100 tons per day to 250 tons per day (not to exceed a maximum permitted weekly tonnage of 500 tons per week)
- Increase to the days of operation from Tuesday and Wednesday to Monday through Friday
- Increase the hours of operation from 8:00 A.M. to 4:00 P.M. to 8:00 A.M. to 4:30 P.M.
- Update to the estimated closure date from year 2045 to year 2031

This Informational Meeting is for any interested parties to learn more about the revised SWFP and to provide comments to the LEA regarding the proposed action. The decision to approve or deny a revised SWFP will be made by the LEA within 120 days of the date the application was deemed complete (May 4, 2020), and the SWFP will then be submitted to the California Department of Resources Recycling and Recovery (CalRecycle) for concurrence.

Copies of the proposed revised SWFP and application package for San Onofre Landfill are available for public review by appointment only in the LEA office located at 5500 Overland Avenue, Suite 110, San Diego, CA 92123.
